### The History & Heritage of Malta

### 6 days from £969 Departs 14th May 2020

### Day 1

We meet at our designated pick up points and transfer by private coach to Heathrow Airport for our direct scheduled Air Malta flight to Malta. On arrival in Malta we transfer to the 4\* San Antonio Hotel at Qawra for a five night stay on a half board basis.

### Day 2

We visit the Three Megalithic Temples of Tarxien with our guide this morning, first discovered in 1915 and dating back to 3000 BC. The Tarxien Temples are notable for their fine workmanship and decorative carvings, including domestic animals carved in relief and exquisite spiral designs. We continue to Ghar Dalam, 'the Cave of Darkness', and its fossilised remains of prehistoric animals from the glacial period. We then spend some time at leisure for lunch in the nearby picturesque fishing village of Marsaxlokk, with its colourful 'Luzzus', traditional Maltese fishing boats. On arrival in Sliema this afternoon we enjoy an included Grand Harbour cruise, taking in the two natural harbours on either side of Valetta.

### Day 3

Our guide meets us at our hotel this morning and accompanies us throughout the day. Valetta, the capital city of Malta is our destination today, with its fine array of Baroque buildings, palaces and churches. We firstly visit the Upper Barracca Gardens for a panoramic view of the Grand Harbour. We continue to St John's Cathedral to see the famous Caravaggio painting 'The Beheading of St John'. Our visit to the Grandmaster's Palace, which houses Parliament and the offices of the President of Malta, includes a visit to the Tapestry Chamber. We visit the National Museum of Fine Arts this afternoon, located in a palace and home to a fine collection of paintings, including works by Guido Reni, Jusepe Ribera and William Turner.

### Day 4

Our guide accompanies us on our full day excursion to the island of Gozo, meaning 'joy' in Castlian. We drive to Cirkewwa where we embark on a ferry crossing to Gozo, the legendary abode of Calypso, daughter of Atlas. We firstly visit the Ggantija Temples, one of the most important archaeological sites in Malta. Round in shape and containing statues of full figured goddesses, the Ggantija Temples were dedicated to the Great Mother Earth and probably included an oracle. One of the Ggantija Temples is the oldest stone structure in the world, predating Stonehenge and the Great Pyramids by hundreds of years. We continue to Calypso's Cave, the legendary home of Ulysses for breathtaking views of the red sands of Ramla Bay. We then spend some time at leisure for lunch in the picturesque resort of Xlendi. We continue to Victoria, the capital of Gozo. Time is at leisure to explore the town, or you may choose to accompany our guide on an uphill walk to the Citadel, to visit St Mary's Cathedral, erected shortly after the earthquake of 1693. We return by ferry back to Cirkewwa.

### Day 5

We firstly visit Mdina, the ancient capital city of Malta. Locally known as the 'Silent City', our guided tour takes in the defence bastions dating back to the 9th century and St Peter and St Paul's Cathedral. We continue to Rabat to see the famous Catacombs of St Paul. Used in Roman times to bury the dead, the Catacombs were also used as a secret meeting place by early Christians.

### Day 6

This morning we visit the National War Museum, located within the fortified walls of Fort St. Elmo, and home to a fine collection of artefacts. Displayed in a chronological manner, these artefacts narrate the military history of Malta from the early phases of the Bronze Age, around 2,500 BC when the first inhabitants arrived from Sicily, to Malta's EU Accession in 2004. We transfer by coach to Malta Airport for our direct scheduled Air Malta flight to Heathrow, and onwards coach travel back to our original pick up points.

NB:- Please note we reserve the right to alter the above itinerary if required for operational reasons. Given the historic nature of the places visited, a certain degree of walking will be involved, and this holiday may not be suitable for those with mobility problems.

It is important that you read the following conditions together with additional general information contained within the brochure for your holiday. In these Booking Conditions, "we", "us" and "our" are Tailored Travel Limited.

### 1. HOLIDAY PAYMENT

- (b) those of a third party not connected with the provision of your holiday and which were unforeseeable or unavoidable or
- (c) an event which either ourselves or the supplier of the service(s) in question could not have foreseen or avoided even with all due care.
- 3. We limit the maximum amount we may have to pay you for any and all claims or parts of claims which do not involve personal injury, illness or death. Except where loss and/or damage to or of luggage or personal possessions is concerned or a lower limitation of little and the claim, the maximum amount we will have to pay you for such non-personal injury claims if we are found lable to you on any basis is twice the price (excluding insurance premiums and amendment charges) paid by or on behalf of the person(s) affected in total.
- 4. Where we are found liable for loss of and/or damage to any luggage or personal possessions (including money), the maximum amount we will have to pay you is \$60 per person affected as you are assumed to have taken out travel insurance which is adequate or your requirements.
- 5. It is a condition of the acceptance of liability set out in clauses 18(1) and 18(2) of these Booking Conditions that you notify us of any claim you or any member(s) of your party has in accordance with the procedure set out in clause 17, "COMPLAINTS PROCEURE". Any person to whom any payment is made must also assign to ourselves or our insurers any rights they may have to pursue any third party in connection with the claim. You must also provide ourselves and our insurers with all assistance we may reasonably require.
- 6. Except where otherwise expressly stated in these booking conditions, where any claim or part of a claim concerns or is based on any travel arrangements (including the process of getting on or off the transport concerned) provided by any carrier or any stay in a hotel, the maximum we will have to pay you in respect of that claim or part of a claim if we are found liable to you on any basis is the maximum which would be payable by the carrier or hotel keeper concerned under the applicable international conventions (e.g., Warsaw convention as amended for international travel by air and/or for carriers with an operating licence granted by an EU. Country, the EU. Regulation on air carrier liability for any travel by air) in that situation.
- 7. Please note, we cannot accept any liability for any damage, loss, expense or other sum(s) of any description which (a) on the basis of the information given to us by you concerning your booking prior to our accepting it, we could not have foreseen you would suffer or incur if we breached our contract with you or (b) did not result from any breach of contract or any other fault by ourselves or our employees or, where we are responsible for them, our suppliers. Additionally, we cannot accept liability for any business losses.

### 19. PASSENGERS WITH A DISABILITY

Please note, our holidays may not be suitable for people with certain disabilities or medical conditions. If you have a disability, coaches can



be difficult to get on and off and some of our hotels do not offer ground/lower floor accommodation or lifts/easy access. Should any member of your party suffer from any disability or medical condition which may affect their or other people's holidays you must provide full written details at the time you book the holiday notuculting any specific requirements that person has. Additionally at the time you book the holiday you must provide written confirmation that all assistance the person concerned requires will be provided by other party members as outside assistance will not be available. In view of the nature of our holidays, we report we must reserve the right to decline any booking whenever we feel unable to accommodate the needs of any particular client or where, in our opinion, the medical condition or disability of the client concerned is likely to have a significant adverse effect on other clients taking the same holiday. We further reserve the right to cancel any holiday and impose cancellation charges if we are not fully advised of any relevant disability or medical condition at the time the booking is made. This does not affect your statutory rights.

### 20. INDEMNITY

If your actions or those of any member of your party cause damage to the accommodation in which you are staying or to the vehicle, train, ship or aircraft in which you are travelling, or cause delay or diversion to any means of transportation, you agree to fully indennify us against any claim (including legal costs of all concerned) made against us by or on behalf of the owners of such accommodation or the operator of such means of transportation or by any third party.

### 21. INFORMATION REFERRING TO OUR TOURS

We always endeavour to give precise, accurate information to telephone enquiries. However, we cannot accept liability for information given orally to customers unless it is confirmed by us in writing.

### 22. PASSPORTS, VISAS. ETC.

It is your responsibility to ensure that you and those for whom you are booking are in possession of valid passports and any appropriate visas. Be sure to check passport and visa requirements with the consulatives of countries being travelled through well in advance. You are responsible for any charges, fines etc, that may be levied by authorities in the vior overseas for non compliance with regulations in the area and any such amounts will be recharged to you. You will not be permitted to travel overseas without an appropriate passport and all applicable visas. UK passports should be valid for at least 3 months beyond your planned date of return to the UK.

### 23. FLIGHTS

We are not always in a position to confirm the airline, aircraft type and airport of departure or destination which will be used for your holiday at the time of booking. Where this information is provided at any time, any change will be treated as a "minor change" not be tritling you to cancel or change to another holiday without paying our normal charges.

### 24. PERSONAL DETAILS

We may have to pass on certain details to a company or organisation (for example, the airline, hotel or credit card company) in order that your holiday or other service or product can be provided. We may be required to provide information by law as permitted by the EU General Data Protection Requition (GDPP) and/or the Data Protection Act 2018 or by a legal authority. When you make a booking or enter into a transaction this means you consent to our passing on such details in all such circumstances. We will also use the information you provide to send you details about our products and services now and in the future. We may also pass your details to third parties working on our behalf. If you do not want us to do this you must write to the Data Controller, at our head office address. We will not sell or pass your details to any individual or company which is not a subsidiary or parent of ours without your prior consent except in the circumstances shown above. You are entitled to see a copy of all the data we hold relating to you personally.

### 25. CONSISTENCY

In the event of any inconsistency between these Terms and Conditions and the additional general information in the brochure, these Terms and Conditions will apply in respect of the inconsistency.

### 26. YOUR FINANCIAL PROTECTION

- The air holidays and flights in the brochure are ATOL protected, since we hold an Air Travel Organiser's Licence granted by the Civil Aviation Authority, Our ATOL number is ATOL 5605. In the unlikely event of our insolvency, the CAA will ensure that you are not stranded abroad and will arrange to refund any money you have paid for an advance booking. - 2. When you buy an ATOL protected flight inclusive holiday from us you will receive an ATOL Certificate. This lists what is financially protected, where you can get information on what this means for you and who to contact if things go wrong.
